MISS RODEO AMERICA, INC. Eligibility Requirements- MRA Pageant held in 2025

By signing below, I confirm that I meet all of the eligibility requirements set forth below.

1. **Age:** I will be 21 years of age by November 1, 2025 and I will be no older than 26 years of age by December 31, 2025. Upon request, I will provide a copy of a government issued identification (such as a birth certificate, driver's license, passport, etc.) verifying my age.
2. **U.S. Citizen:** I am a citizen or lawful resident of the United States of America and authorized to work in the United States of America.
3. **Resident of State:** I am a resident of the State where I will compete or have competed in the State Pageant.
4. **Education:** I have obtained a high school diploma (or equivalent).
5. **Gender:** I was assigned female at birth, and I am female.
6. **Marital Status:** I am not currently married and have never been married.
7. **Parental Status:** I am not a parent of any child and I am not pregnant.
8. **Good Character:** I am of good moral character. I have never committed or been involved in an act of moral turpitude.
9. **No Criminal Record:** I have not been convicted of any felony or misdemeanor crime (excluding minor traffic offenses). I agree to allow MRAI to run a background check.
10. **Health:** I am in good health and I do not have any health concerns which would prevent me from fully participating in this contest or from serving as Miss Rodeo America if selected.
11. **Substance Abuse:** I do not use any illegal or controlled substances (other than prescription medications and then only in the manner prescribed). I do not abuse alcohol or drugs.
